



CUT-OFF DATES

Cut-off dates (the last day of the qualifying month) must be adhered to, as eligibility for your employees is determined by these dates. Reporting dates that overlap these cut-off dates cannot be processed.

Please Note: Pursuant to the MPI Trust Agreements, contributions are due on a weekly basis and shall be deemed due within 5 days of the close of each payroll week, and will become delinquent 5 days thereafter.
