#### ASSISTANCE UPDATE

The Motion Picture Industry Pension & Health Plans ("MPI") are dedicated to assisting those Participants who have suffered loss as a result of the recent fires in Los Angeles and Ventura counties. This piece is designed to provide Participants with information about the various benefits available to them in response to these disasters.

# An Individual Account Plan Hardship Withdrawal Opportunity Will Be Available Beginning February 3, 2025

Beginning February 3, 2025, those Participants who meet the following conditions may apply for a special one-time early withdrawal of an elected amount up to 20% of their 2023 IAP balance (less any IAP hardship withdrawal taken in 2024), not to exceed a maximum dollar amount of \$22,000, prior to any tax obligations:

- 1) who are vested with the Motion Picture Industry Individual Account Plan ("IAP");
- 2) whose home address on file with MPI as of January 1, 2025 is in the County of Los Angeles (i.e., the FEMA-designated disaster area); and
- 3) who sustained an economic loss by reason of the disaster.

This one-time option will be available February 3, 2025 through July 5, 2025 (180 days following the date of the applicable FEMA disaster declaration). If a Participant previously took a withdrawal in 2020, 2023 and/or 2024, he or she is still eligible for this opportunity.

This one-time distribution will not be taxable so long as it is repaid to the IAP within three years' time. If the amount is not repaid, regular federal income tax and state tax will apply. Please, note tax withholding is optional. In addition, Participants should consult with their tax advisor on any potential tax implications.

If a Participant's IAP account balance is \$5,000 or higher and the Participant is married, then spousal consent is required before a hardship withdrawal will be granted. Spousal consent

requires witness of a spouse's signature in the presence of a notary public or an MPI representative.

IAP hardship withdrawal applications will be reviewed by MPI staff and approved for processing within 30 days of receipt of the application and all supporting documentation.

Participants with addresses on file with MPI and in the following ZIP codes will be able to apply for the IAP Hardship Withdrawal if the aforementioned conditions are met:

### **Waiver of Premiums Due is Available to Certain Participants**

For Participants with a Los Angeles County or Ventura County home address on file with MPI as of January 1, 2025, MPI will grant a waiver of premiums for health benefits due for January, February and March 2025 to each Active Health Plan Participant (who is subject to premium payments for active coverage for themselves and/or their dependents) who was eligible and enrolled on January 1, 2025, if the ZIP code of their home address on file with MPI was in a mandatory fire evacuation zone.

While there will be no refunds, Participants who have already paid a premium for the applicable period will be issued a credit for the next premium payment period.

Participants who are eligible for this benefit will be contacted by MPI directly. As of the date of this notice, Participants who are eligible for this benefit must have an address on file with MPI that falls within one of the following ZIP codes:

# Waiver of COBRA Premiums Due is Available to Certain Participants

For Participants with a Los Angeles County or Ventura County home address on file with MPI as of January 1, 2025, MPI will grant a waiver of COBRA premiums for health benefits due for January, February and March 2025 to each MPI Participant enrolled in COBRA on January 1, 2025 if the ZIP code of their home address on file with MPI was in a mandatory fire evacuation zone and the Participant was displaced for two weeks (14 days) or more from their home due to the disaster.

While there will be no refunds, Participants who have already paid a COBRA premium for the applicable period will be issued a credit for the next premium payment period.

Participants who are eligible for this benefit will be contacted by MPI directly. As of the date of this notice, Participants who are eligible for this benefit must have an address on file with MPI that falls within one of the following ZIP codes:

### Replacement Glasses May Be Available

Participants who have lost or broken glasses due to the fires, may contact VSP at (800) 877-7195 to get assistance. Replacement glasses may be available even if the benefit was previously used.

Individuals without VSP coverage can contact their local American Red Cross chapter or shelter, or call (800) 733-2767, to ask about support for replacement eyewear, which may include VSP Eyes of Hope gift certificates or an alternative solution.

### **Early Refills of Medications**

Participants who reside in Los Angeles and Ventura counties may request refills of their prescription medications lost during the fires. To do so, Participants can visit any in-network pharmacy and request a refill of their medications. The pharmacy staff will enter a code that will allow a refill of the prescription. Pharmacy staff are aware of this code. Also, CVS Specialty Pharmacy can make early refills and ship medications to alternate locations, if needed.
